COMPLAINT BY MR. FARR

<u>Discussion</u>. Mr. Dave Farr addressed the members of the Executive Committee regarding a formal complaint that he had made. Extensive discussions took place in-camera and allowed to resolve the complaint to the satisfaction of Mr. Farr.

ATOM LOCAL LEAGUE COMPLAINT

<u>Discussion</u>. The Executive Committee members were presented with a complaint concerning the conduct of a player from an Atom Local League player. Extensive discussions took place in-camera but failed to fully resolve the matter.

2016/2017 REGISTRATION FEES

<u>Discussion</u>. The Secretary had sent a proposal to the Executive Committee members for next season's registration fee structure. With the first registration event being approximately two months away at the AGM, any change to the registration fee structure needs to be reviewed and approved relatively quickly. Unfortunately, the committee members were unable to reach consensus and tabled the discussion to the next regular meeting.

REFEREE SALARIES Res. #16-02-05

<u>Discussion</u>. As a follow-up to previous discussions on the subject of a possible increase in referee fees, the members of the Executive Committee were presented with information regarding decisions made by neighboring associations (i.e. Elmvale, Stayner, Collingwood) with regards to referee salaries. The President also read letters received from some Wasaga Beach referees pleading for an increase in salaries in all divisions in order to help recruit and retain young referees. Other recruiting and retention methods were discussed, but in the absence of the Referee in Chief, the discussion ended with a recommendation from the OMHA Rep to do the same than what other associations in the region are doing. A resolution was therefore drafted that mirrors what had been discussed at the last OMHA meeting.
