President Report/Address Thur 19 October 2023

1-Town Deputation:

Presentation was on the 28 th Sep 2023 at Town Chambers Hall

It was explained that numbers are down some, reasons that being cost, result of covid years and kids not returning, kids going to other centers A, AA etc

Received a follow up call from Town member Gerry Miller requesting to meet to discuss how town can help increase numbers again – meeting has not yet happened because of scheduling 2-Amalgamation:

Meeting hosted by WBMHA- Participants, Clearview, Elmavale, Essa and Wasaga and Adam Parent OMHA

General conversation on interest – all centers interested

Many centers are now engaged in this process, more and smaller centers area amalgamating because of numbers.

OMHA is strongly entertaining this process

Types of amalgamations:

1-Total – all become one with new name

2-Hybrid- new center created and classified as A or AA because of total numbers (975), create new center for the A or AA(Stand alone) but home centers retain identity i.e.: Wasaga Stars LL This option will also provide each center to host a rep team as well

3-Zone- the new area would remain the same, and only support LL. OR move the Center point for the area and re map or re-boundary the area for all centers

Centers to return to executive, present the noted 3 options for discussion and what is best for each party. Develop a plan on how to canvass membership for input and awareness

Association member met with Coach Liaison and me and 2 independent witnesses. Discussion stemmed from members thoughts and opinions and requests regarding actions of a coach. The review of past history was discussed and it was agreed upon from both sides that no further action was going to take place. Also upon review of a video in question the actions of the child and coach had been discussed. Both the parent and Coach Liaison and I agreed to disagree on interpretation of

said video.

When questioned as to the wishes of the parent moving forward, -a-for the coach to be removed... The reply was as follows...the coach went through the selection process, won the competition, and will be the coach – that we only have the one team for 2023/24 season.

The second request was for the child not to communicate with the coach and use the trainer-request denied – explanation given was Further the trainer for any team is solely responsible for the children s safety on any team and not other duties, i.e.: opening the door, coaching the D or communicating different plays. The parent was also denied this request.
